DELHI SUSTAINABLE DEVELOPMENT SUMMIT

The DSDS (Delhi Sustainable Development Summit) is an annual flagship event of TERI being organized since 2001. It is a global forum that seeks to provide long-term solutions for sustainable development. It has witnessed participation by global stakeholders including heads of state/government, ministers, and dignitaries comprising Nobel laureates, development practitioners, scientists, academicians, and corporate leaders from across the world.

DSDS 2009

The summit in 2009 would seek to reinforce the climate change agenda of the previous year. It would sharpen the focus on the theme **Towards Copenhagen: an equitable and ethical approach**, to arrive at a global consensus on climate change beyond 2012. Industry leaders, opinion-makers, and climate change experts will gather to create a uniform level of understanding among all stakeholders and formulate meaningful policy options for a constructive dialogue on climate change and try to arrive at an agreement.

International Climate Change Exhibition

The DSDS 2009 will revisit the ICCE (International Climate Change Exhibition) of last year, offering a credible platform for companies to display their new technologies, products, and services driven towards addressing adverse effects of climate change.

Screening Films on Climate Change

CEO FORUM 2009

Curtain raiser to DSDS

It is the most popular feature of DSDS. The CEO Forum will focus on the theme **Climate Change: perspective from the change makers in business**. It will review issues and address the challenges businesses are likely to face due to climate change. Focus will be on 'how' and 'why' green is good. Business opportunities in the emerging scenario will be examined. Action on energy efficiency, introduction of clean technologies, finance, insurance, changes in business lifestyles, and host of other unexplored areas will be discussed in this forum.

DSDS 2009 SUB-THEMES

- Climate change challenge: engaging all stakeholders for global consensus**
 - Deliberate on ethical and equitable dimensions
 - Multi-stakeholder approach based on CBDR (common but differentiated responsibilities) principle.
 - Reference to IPCC (Intergovernmental Panel on Climate Change), BAP (Bali Action Plan), and other international processes.
 - Focus on the imperatives provided by the scientific assessment of the IPCC, the momentum of Bali and Poznan and opportunities for business.
- Global finance and technology transfer**
 - Finance and technology transfer to strengthen adaptation practices and facilitate low carbon growth in developing countries.
 - Countries both developing as well as developed to meet 'measurable, verifiable, and reportable' criteria based on equity principles.
 - Specific scenarios involving different regimes for the above issues will be presented and discussed.
- Adaptation to climate change impacts**
 - Strengthen the capacities of developing countries
 - Understand adaptation needs
 - Identify priorities and undertake adaptation action
 - Special focus on key vulnerabilities and global responses to assist developing countries in creating adequate capacity for adaptation.
- Mitigating GHG emissions**
 - Deep cuts in emissions in the new agreement
 - Measuring and monitoring GHG emissions in absolute or per capita basis and its implications.
 - Develop consistent and transparent methodology to measure and reduce emissions.
 - Discuss and evolve concrete action plans for the term 'measurable, quantifiable, and nationally appropriate' climate change mitigation policies of Bali plan.
 - Avoided deforestation as a mitigation option
- Develop national and international policies focusing on avoided deforestation.**
- A common approach agreement to look into the advantages and concerns of forest resources conservation as a means to reduce emissions.**
- Co-benefits of avoided deforestation as a mitigation option and concerns regarding land-use issues.**
- Scope and opportunities provided by REDD (Reducing Emissions from Deforestation in Developing countries) at the World Bank, its progress since Bali, and its strategies for an outcome at Copenhagen 2009.**
- Incentives for conservation such as SFM (sustainable forest management), in the form of compensated conservation through market mechanism or funds.**
- Specific countries affected by deforestation to provide insights regarding particular policies.**
- Dealing with impacts, adaptation, and vulnerability: the challenge for Africa**
 - Create capacity by which various parts of Africa could assess specific impacts of climate change and come up with adaptation measures.
 - Focus will be on agriculture, rural development, land, and desertification.
 - Role of international organizations and the global community
- Media: editorial on climate change**
 - An exclusive editors' panel highlighting media's response to climate change.
 - Discussions on sustainable lifestyles and technologies
 - Feedback survey, before and during the summit, to analyse individual life styles and measure individuals' willingness to change.
- Imperatives of change process: Bali-Poznan-Copenhagen**
 - Review existing international process to frame post- 2012 climate change regime.
