

OM PRAKASH MATHUR

Om Prakash Mathur is Senior Fellow and Head, Urban Studies at the Institute of Social Sciences, New Delhi and has served as a Distinguished Professor of Urban Economics at the National Institute of Urban Affairs, New Delhi, from 2011-2013. He has held the IDFC Chair in Urban Economics and Finance at the National Institute of Public Finance and Policy, New Delhi for over 15 years. He held the position of Director, National Institute of Urban Affairs, New Delhi from 1984 – 1992. His earlier assignments include: Senior Economic Planner at the United Nations Centre for Regional Development, Nagoya, Japan (1978-1984); UN Senior Regional Planning Advisor/Project Manager, Imperial Government of Iran (1975-78); and Director, Multi-level Planning Division, Planning Commission, Government of India (1971-75). He has served as a short term Consultant to the United Nations University, the World Bank, Asian Development Bank, UNCHS, UNDP, UNICEF, UNESCAP, Bangkok and Asian Productivity Organisation, Tokyo. Together with other faculty members of the NIPFP, Om Prakash Mathur worked with the Finance Commission, Government of Sri Lanka on defining fiscal relations between the Central government and provincial governments, and with the Local Government Finance Commission, Uganda, on the Commission's capacity building programme. He holds a Master's degree in Economics from the Delhi School of Economics, and has attended graduate courses at the Massachusetts Institute of Technology and Harvard University, Cambridge (Mass: USA).

Om Prakash Mathur was a member of the Prime Minister's National Review Committee on Jawaharlal Nehru National Urban Renewal Mission (JNNURM). He was a member of the Academic Panel of McKinsey Group working on India's urban sector and of the High Powered Expert Committee on Estimating Investment Requirements for Urban Infrastructure, chaired by Dr. Isher Ahluwalia. Om Prakash Mathur is member of the Advisory Board of the ADB-GIZ sponsored City Development Initiative for Asia (CDIA), and a non-resident Senior Fellow of the Global Cities Institute, University of Toronto.

Om Prakash Mathur has served over the period 1994-2002, a member of the Finance Commission of three states, namely, Delhi, Madhya Pradesh, and Punjab. The Finance Commissions of states are constituted, once every five years, under a provision of the Constitution of India, and are required to make recommendations on (i) the taxes, duties and levies which should be assigned to, or devolved on, local governments, (ii) the revenue-sharing arrangements between the state and local governments, and (iii) the grants-in-aid system for local governments. Om Prakash Mathur was a member of the Expert Committee on Auto Fuel Policy set up by the Government of India *inter-alia*, to recommend an auto fuel policy for India taking into account the vehicular emission norms.

Om Prakash Mathur has served as a member of the International Advisory Board, representing Asia, of the UNDP/UNCHS/World Bank executed Urban Management Programme, a member of the UN-Habitat's Advisory Group of Experts on Decentralization (AGRED), a member of the Advisory Board of UN Global Research Network on Human Settlements (2004-07) and a member of the Steering Committee constituted by the European Commission to assist in the identification and implementation of urban sector projects in Asia, under its Asia Urbs Programme.
