### Introduction

The perils posed by the erratic changes in the earth's climate, the imbalances in its biodiversity, and the alarming depletion of its natural resources leave us with no option but to operationalize the 'sustainability' of our development. Taking up the responsibility of providing knowledge and stimulating debate on various aspects of sustainable development, TERI organizes the annual, international DSDS (Delhi Sustainable Development Summit). Launched in 2001, it has emerged as the developing world's sole forum on global sustainability issues. It assembles the finest minds of the world to deliberate on specific themes and formulate approaches to sustainable development.

While the first two editions of the DSDS created the space and occasion for debates on issues such as 'poverty' and 'livelihoods', DSDS 2003 dealt with the larger development priorities set in the WSSD (World Summit on Sustainable Development) in Johannesburg. DSDS 2004 seeks answers to some niggling questions in the context of the progress in implementing the agenda and approach evolved in Johannesburg.

Intensive deliberations at the WSSD resulted in a significant outcome: partnerships for sustainable development involving governments, corporates, funding agencies, scientific and technology concerns, and civil society groups, aimed at implementing agendas built around the WEHAB (water, energy, health, agriculture, and biodiversity) themes. While an encouraging number of partnerships have come up and a considerable amount of funding has already been committed, we still need to assimilate the lessons learnt since the WSSD and project the way forward. DSDS 2004 titled Partnerships for sustainable development: addressing the WEHAB agenda - will essentially focus on, analyse, and assess innovative partnerships in the post-WSSD scenario.

#### *Plenary session 1* 10.15 a.m.-11.50 a.m. The water and sanitation challenge: How complex? How urgent?

Provision of good water and sanitation services is a prerequisite to achieving several Millennium Development Goals. However, measures for promoting sustainable water use are far from satisfactory, with about 1.2 billion people still lacking access to safe drinking water and 2.4 billion lacking adequate sanitation facilities. The ever-increasing competition for water affects the poor most, especially women and children who have to walk miles to fetch water to meet basic household needs. Is enough being done to make the delivery and management of water services more participatory? How should the regulatory, management, and financial aspects of these services be strengthened? How can cross-sectoral management of water resources be improved?

About 70% of the poor people in developing countries live in rural areas and depend directly or indirectly on agriculture for livelihoods. These people and entire economies are now threatened by the impacts of unsustainable agricultural policies and practices on the natural resource base.
